

Terms of Reference

Senior Consultant – Healthcare Technology

National Health Systems Resource Centre (NHSRC) has been set up under the National Health Mission (NHM) as an autonomous registered society, to channelize technical assistance and capacity building support to the states for strengthening the public health system. The NHSRC is also mandated to contribute towards National strategic health planning and programme design.

NHSRC intends recruiting Senior Consultant – Healthcare Technology purely on contractual basis.

Role and Responsibilities:

- Under leadership of Advisor - Healthcare Technology, carry out the work of technology division and develop and implement work plan.
- Support identification-assessment and uptake of health technology innovations as per MoH&FW approved process & procedures.
- Support market research surveys on health products when requested by Ministry of Health & Family Welfare and other related Ministries.
- Support the identification, assessment and uptake of health technology innovations as identified in the National Health Innovation Portal
- Formulating and supporting implementation of technology intensive health programs such as Free Diagnostics & District Dialysis Program.
- Providing technical assistance to Ministry of Health & Family Welfare, other related Ministries & State government in technology trade policy, tariff structures and technology transfers.
- Undertake other assignments, which may be assigned from time to time by the Advisor - Healthcare Technologies.
- Work closely with other divisions within NHSRC, RRC-NE and other stakeholders.
- Work as OIC when Advisor - Healthcare Technology is away on travel or leave.

Eligibility:

- BE / B. Tech in Biomedical Engineering with Minimum 5 years of post-qualification work experience in healthcare services, industry, manufacturing, hospital administration or a mix of these.
- Experience in Technical Specifications, Procurement and Maintenance of high end medical equipment will be an added advantage
- Competency and experience of working on NHM programs at policy level / implementation level on healthcare technology innovations/any other medical devices/ equipment procurement/specification etc will be an added advantage.
- Demonstrated experience in operationalizing health programs at field level; working in strengthening health systems
- Demonstrated experience of operationalising health programs at field level; health systems strengthening with Knowledge on latest development in Medical Technology
- Demonstrated ability to work in a multi-disciplinary team environment along-with excellent communication, presentation skills and interpersonal abilities.
- Preference will be given to candidates who have relevant experience working at national / state level
- Educational qualification, experience & age could be relaxed for exceptional candidates.
