Terms of Reference Fellow – Public Health Planning

National Health Systems Resource Centre (NHSRC) has been set up under the National Health Mission (NHM) as an autonomous registered society, to channelize technical assistance and capacity building support to the states for strengthening the public health system. - 6. Undertake other assignments, which may be assigned from time to time by the Advisor Public Health Planning / Executive Director, NHSRC.

- Any graduate with Master Degree in Public Health/ Community health, Preventive & Social Medicine.
- It is desirable to have some post qualification work experience in Health Systems Research or in Planning and implementation of service delivery. However, it is not mandatory
