Against a Resource Envelope of **Rs.44.30 Crore** (calculated with State Share of 10%) as conveyed vide Secretary (H&FW)'s letter dated 14th July 2021, approval of the competent authority is hereby conveyed to the State of Mizoram for an additional amount of **Rs.3.57 Crore** for strengthening of oxygen infrastructure through PSA/LMO and MGPS system under COVID-19 Emergency Response and Health System Preparedness Package: Phase-II for implementation from 01.07.2021 to 31.03.2022.

All the conditionalities outlined under the ECRP-II approvals communicated vide letter No. Z.15015/43/2021- NHM-I dated 13th August 2021 for an amount of **Rs.37.93 Crores** and letter No. Z.15015/43/2021- NHM-I dated 24th September 2021 for an amount of **Rs.2.80 Crores** are applicable to supplementary approvals for ECRP-II also, unless stated otherwise and need to be meticulously adhered to by the State Government.
