This refers to supplementary proposal submitted under Emergency COVID Response Package: Phase-II by the State of West Bengal amounting Rs. 250.79 Crore vide Letter No. HFW/NHM-322/2021/2722 dated 13.09.2021 and email dated 05.10.2021.

2. Against a Resource Envelope of **Rs. 1007.93 Crore** (calculated with State Share of 40%) as conveyed vide Secretary (H&FW)'s letter dated 14<sup>th</sup> July 2021, approval of the competent authority is hereby conveyed to the State of West Bengal for an amount of **Rs. 250.79 Crore** under COVID-19 Emergency Response and Health System Preparedness Package: Phase-II for implementation from 01.07.2021 to 31.03.2022.
