#### MEMORANDUM OF ASSOCIATION

Name of the Society

The name of the Society shall be the "National Health Systems Resource Centre", New Delhi, hereinafter referred to as 'NHSRC'.

## 2. Area of operation

The area of operation of the Society shall be the whole of India.

#### 3. Location

The registered office of the Centre shall be situated in the Union Territory of Delhi or the National Capital Region (NCR) of the India, presently at National Institute of Health & Family Welfare, Munirka, New Delhi.

## 4. Objective

Strategic planning and development of the Health and Family Welfare sector in India particularly capacity development of related organizations at the Central, State and Districts levels with a view to promoting health sector reforms to facilitate planning, implementation, monitoring and evaluation of sectoral policies and programmes with particular reference to the National Rural Health Mission.

All the income earning, moveable and immovable properties of the Societies shall be solely utilized and applied towards the promotion of its aim and objects only as set forth in the Memorandum of Association and no profit there of shall be paid or transferred directly or indirectly by way of dividends, bonus, profits or in

any manner whatsoever to the present, past or future members of the Society.

No member of the Society shall have any personal claim on any moveable or immovable properties of the Society or make any profit, howsoever by virtue of his/ her membership.

### 5. Functions

- 5.1 To achieve the above objectives, the society shall carry out the following functions:
  - 5.1.1 To promote and support good governance in the health sector.
  - 5.1.2 To facilitate professional Human Resource Management in the Health & Family Welfare sector including Organisational Development and Behavior, Recruitment, Training, Placement, Performance Appraisal, Career Development, Succession Planning etc. of health sector personnel.
  - 5.1.3 To Provide support for Capacity Development for achieving the health outcomes and objectives to government and non-government institutions and organizations at Central, State, District and Sub-District levels.
  - 5.1.4 To create a pool of institutions and individuals to provide capacity support.
  - 5.1.5 To provide evidence based insights on wider determinants of health outcomes for planning of the Health Sector at the National, State and District levels.
  - 5.1.6 To develop frameworks for pro-poor innovations that reduce out of pocket expenditure and disease burden of poor households.

- 5.1.7 To facilitate partnerships between different stakeholders including the Central, State and Local Governments.
- 5.1.8 To provide support for efficient implementation of National Rural HealthMission at Central, State, District and Sub District levels
- 5.1.9 To develop a state of the art monitoring and evaluation system based on latest innovations and technology.
- 5.1.10 To facilitate and design systems for improving transparency, accountability, community participation and technological innovations in the Health & Family Welfare systems.
- 5.1.11 To be the focal point for knowledge management, documentation and dissemination of knowledge and experiences as well as good practices in health systems in India and across the world.
- 5.1.12 To provide policy advice to the Central and State Governments including on matters specifically referred to it pertaining to the Health and Family Welfare sector.
- 5,1.13 To promote and undertake analytical work to continuously improve the planning, implementation, monitoring and review of the health sector reforms.
- 5.1.14 To facilitate induction and development of new professional skills in the system including contracting and management of national and international consultants/ institutions to meet the needs of the sector.

State, District, Sub-District and Facility levels through adoption of IT based Management Information Systems and modern Management practices in the areas of Personnel, Finance, Materials (procurement and logistics), Estates and Customer Relations Management.

- 5.1.16 To collaborate with National and State Institutes of Health and Family Welfare, International Institute for Population Sciences, Population Research Centers, Academic institutions specializing in health sector, State and Regional level Health Resource Centers and Programme Management Units at different levels in mutually agreed areas.
- 5.1.17 To promote and facilitate public-private partnerships in the Health & Family Welfare sector.
- 5.1.18 To undertake any other function entrusted to it by the Governing Body or the executive committee.
- \$.2 For performing these functions the society shall:
  - 5.2.1 Establish and carry out the administration and management of the Society's Secretariat, which will serve as the implementation arm of the Society.
  - 5.2.2 Create administrative, technical and other posts in the Secretariat of the Society as deemed necessary.
  - 5.2.3 Employ, retain or dismiss personnel as required.
  - 5.2.4 Establish its own salary and other allowances package for its employees.
  - 5.2.5 Establish its own procurement procedures and employ the same for procurement of goods and services.
